ADOPTION SUPPORT NETWORK - THE ADOPTION SUPPORT NETWORK (ASN) PROVIDES SUPPORT TO ADOPTIVE PARENTS ACROSS MINNESOTA. DURING 2016, ASN OPERATED 28 SUPPORT GROUPS AND PROVIDED ONE-ON-ONE PEER SUPPORT TO HUNDREDS OF ADOPTIVE FAMILIES. THE ASN PRIVATE FACEBOOK GROUPS HAD MORE THAN 1,300 MEMBERS WHO SHARED RESOURCES WITH ONE ANOTHER AND PROVIDED MUTUAL SUPPORT DURING DIFFICULT TIMES. STAFF ALSO PROVIDED ONE-ON-ONE SUPPORT TO SEVERAL HUNDRED FAMILIES.
